BOARD COMMITTEES

Committees are an important element of a board's governance processes that aid it in the fulfillment of its governance role. The general rule is that a board establishes the committees that it requires to assist with the work of the board.

The number of committees, their terms of reference and composition can all be decided upon by the board in the exercise of its discretion. Committees can provide valuable insight to the board and/or staff and serve as an important training ground for future leaders.

1. DEFINITIONS

Standing Committees

The CFUW Ontario Council Board of Directors has implemented eight (8) Board Standing Committees. A Standing Committee is constituted to perform a continuous function. It remains in existence permanently until a motion to strike it from the bylaws is passed by a 2/3 vote of the assembly at an annual or special general meeting.

CFUW Ontario Council has the following Standing Committees: Advocacy; Articles and Bylaws; Education; Finance; Governance; Legislation; Membership; Resolutions; Status of Women and Human Rights.

1. Chairing a committee requires considerable commitment. Committee Chairs are **Members of the CFUW Ontario Council Board** and expected to create an action plan, produce agendas and minutes, conduct follow ups, and communicate with committee members.
2. Committees typically meet by approximately once a month depending on the volume of work. There is also opportunity to meet at the OC Speakers Series.
3. Members are expected to commit to meetings and to bring expertise/experience to the group that will further the mandate of each committee. It is also an opportunity to learn more about the subject area.
